ASX has advised to start a new electronic form as the processing of ASX Online forms was interrupted on 1 December 2025.

LNW is conducting an on-market buy-back of up to approx. US\$631.2m, which does not reflect 2,386,753 CDIs/shares (for approx. A\$331,198,773.14) bought back as at 1 December 2025.

LNW may, at its discretion, vary the size of the buy-back subject to legal restrictions and retains the discretion to purchase a lesser value of securities than indicated or no securities at all.
